

#### Early Evaluation: Consultations by Referral Type

About 40% of referrals came from GP surgery signposting/ referral

A small number from Solent sexual health services




#### Reasons for no supply being issued

Of 422 consultations, 5.9% resulted in no contraception being issued. Reasons for this are displayed in figure 4 (opposite).

One pharmacist of those interviewed reported having to refuse a supply due to safety concerns and referred the patient back to their GP.

In a survey of contracted pharmacists, none reported any safety incidents to date (19 responses).



#### Age of patients seen, contraception types and duration of supply

Younger patients are more likely to be supplied combined oral contraception (COC) whilst those aged 35 and over are more likely to be supplied Progestogen only contraceptive pill (POP). These Patient Group Direction (PGD) supplies are consistent with the previous prescription supply received by the patient, with only two exceptions recorded (i.e. supplied COC having previously been supplied POP). People aged 18-34 years have accessed the service the most, accounting for 61% of consultations. The most common PGD supply durations are 3 and 6 months.







Figure 8: PGD supply duration



### National Advanced Service

- Opt-in for Pharmacies
- Launch date expected to be March 2023
- Service spec & Training requirements published
- Delay due to sign off of IT at NHSE
  - Will have PharmOutcomes for national service
  - Send details of consultation to GP surgery if patient consents



### Tier 2 – Initiation Pilot

- 8 pharmacies registered
  - 2 more eligible once training completed
- Other Portsmouth pharmacies can join Tier 2 pilot (and subsequent Tiers) if they complete 10 consultations of the advanced service
- Different target group of people to Tier 1
  - Less referrals from GP practices
- New PGDs due before end of March
